Business & Community Development

Frank Christopherson, committee member for Planning Commission & Pine City EDA, shared the following highlights:

- » At the August Planning Commission meeting a variance request, submitted by Luke & Leslie Hegge, was reviewed. The request is to re-open the car wash location currently located on the Carpet Unlimited property.
- » The Planning Commission continues to review the 80 page Shoreland Ordinance to address changes recommended by the DNR.

- » No event is being scheduled for October due to the Annual Banquet.

Citizen of the Year

- » We plan to connect with the City of Pine City in hopes of awarding the Citizen Planner and Site Improvement Awards as part of the evenings program.

Chamber Member Updates

- » The City of Pine City met with a new hotel developer last week that is interested in picking up the previous project and continue the progress in Pine City under a new development team.
- » Summit Development has confirmed a ground-breaking event for Tuesday, October 8th for the senior housing project taking place in the Northridge Development area.
- » Hilltop Cottages project has been put on hold temporarily. They are short on their financing package due to some regulatory changes that occurred.
