# President's Report

A motion to nominate Heather Mortiboy to fill the vacancy was made by Christopherson, seconded by Bever. Motion carried.

#### **Executive Director Report**

Schueller provided an update on the Ambassador Program Float project that was shared at the July meeting. The new families have done an amazing job of creating a new and fresh look. The trailer was purchased for \$1,800 from Robert Thompson. Thompson also made a \$500 donation back to the program. Those funds were slated as the budget for the group to use in purchasing materials for the updates.

Schueller also reported that the old trailer is now ready to be sold. Research on the trailer indicated it was a homemade trailer and depending on tires, wiring for lights and the decking condition the likely value is \$500.

A motion to approve the sale of the trailer through public listing with an asking price of \$500 was made by Cummings, and seconded by Samuelson. Motion carried.

The treasurer's report was reviewed. Expenses incurred by the general fund included postage for visitor packet requests, second quarter copier usage, annual worker's comp policy, website hosting renewal, and August payroll. These general fund expenses total \$2,399.36. Freedom Fest expenses totaling \$1,248.83, Ambassador expenses totaling \$4,890.56, and Parade expenses totaling \$3,906.27 were also included in the report. These expenses will be transferred from each of these designated fund accounts. *A motion was made to approve the treasurer's report as presented. Motion was made by Bever, seconded by Cummings. Motion carried.* 

### **Business & Community Development**

Frank Christopherson, committee member for Planning Commission & Pine City EDA, shared the following highlights:

- » At the July Planning Commission meeting, the Yanik-Foster PUD request was tabled until the Shoreland Ordinance could be reviewed.
- » A combined Planning Commission and City Council meeting was held to review a request from Immaculate Conception Catholic Church. They have requested a change to the PUD and want to take down the existing parsonage to plan for future expansion of the church property. A new parsonage will e constructed on the NW corner of the block, to the north of the existing church parking lot.
- » ECE Operation Round-up held their quarterly meeting to review applications. An award for \$10,000 was given to Pine City Youth Hockey for the new concession/warming house/Zamboni storage project.
- » The City of Pine City has sent out an RFP (request for proposals) for interested developers for hotel development in Pine City.
- » Summit Development should have an announcement soon regarding the groundbreaking for their development, just north of the FLHS clinic on Hwy 61.

- » WCMP brought in Mylie's Catering to do food for the Happy Hour in July. Our thanks to both of these businesses for providing an enjoyable evening.
- The August Happy Hour is scheduled for this Thursday, August 8th at Northern Hollow Winery.
